It seeks the dissemination of advanced knowledge and skills among scholars and practitioners of business and applied sciences toward resolving issues and problems of the 21st century. By sharing knowledge, expertise, and facilitating the transfer of know-how across the digital divide, BAASANA programs seek to improve human conditions.

The first BAASANA conference was held during the summer of 2009 in Philadelphia. In the subsequent years, the conference was held in Eastern USA, the UK, Vietnam, and India. More regional conferences in Asia and African Countries will be hosted soon.

Scholarly papers, abstracts, and proposals for the panel from all academic and applied disciplines in business, natural, social, and behavioral sciences, including fields of applied humanities such as journalism, mass communication, legal studies, educational administration, health sciences, environmental engineering, and IT technologies are being invited for presentation at the conference. The Paper Submission Deadline is **September 20, 2023**. Earlier submission is highly encouraged. Since visa formalities and travel arrangements could take months, international participants are advised to submit papers, abstracts, and panel proposals ASAP. Paper/Abstract: Submit a complete paper (page limit: 20 double-spaced pages including tables and references) or an abstract of up to 500 words (the title, authors' name, address, and email address) online via <https://baasana.org/register-for-an-event/>



Conference Registration:

The in-person attendance fee is \$200. The Virtual Conference registration fee is \$100 for presenters/ panelists. The registration fee is 150 if paid by **July 30, 2023**. \$200 if paid after July 30, 2023. A **BAASANA General Annual Membership Fee is \$30 for developing countries and \$50 for developed countries.
